### **MIN 01/9/25: PRAYERS**

The meeting was called to order at 10:30 A.M. and opening prayers were led by Madam Faith Waceke.

### **MIN 02/9/25: AMENDMENT TO AGENDAS**

The agendas of the meeting were not amended and they remained as follows:

- i. Opening and Feedback report from Previous Minutes
- ii. Questions and answers from the Citizens
- iii. Prioritization of Projects
- iv. Any Other Business (A.O.B.)

### **MIN 03/9/25: COMMUNICATION FROM THE CHAIR**

The Vice Chairlady, who was the Chairman of the meeting officially welcomed all the Nanyuki citizens present to the meeting. She thanked all those present and for the good

attendance which indicated interest in the affairs of the New Municipality, especially the development Agenda.

She invited all present to participate and feel free to ask any questions during the meeting. The chair invited the Manager to lead in the introduction of the members and government officials present and continue with the rest of the program for the day.

### **MIN 04/9/25: MANAGER'S REMARKS AND INTRODUCTION OF THOSE PRESENT**

The Manager of Nanyuki Municipality, Mr. Anthony Rukwaro, introduced the staff from both the Municipality and the County Government of Laikipia, representing various departments.

Mr. Rukwaro provided an overview of Nanyuki Municipality, including a map outlining its boundaries. He elaborated on the appointment process for the Board of Management, emphasizing that the Governor's approval facilitated smooth operations and service delivery within Nanyuki Municipality. He also confirmed that the Governor had high expectations on the performance of the Nanyuki municipality and it is the aspiration of the governor to make Nanyuki a 24 hours economy town.

He also outlined the funding model, stating that Nanyuki Municipality qualifies for Ksh 77 million being a grant money from Kenya Urban Support Program and having fulfilled the prerequisite minimum conditions and the performances standards.

### **MIN 05/9/25: REPORT ON PREVIOUS CITIZEN FORA MEETING HELD ON 3RD OCTOBER 2024 & MATTERS ARISING**

The manager briefed the members of the public on the last public fora which had the following matters:

Members sought to know progress on the last forums agendas on projects and grievances touching on Nanyuki town. The manager explained that, since the municipality had not received the resources to work on the grievances raised, the board and the management had written to various county government departments in regards to those concerns and it was trailing those departments to check on progress of the reported issues. Concern was also raised by resident from Likii (reg.no 27) regarding the disposal of diapers and waste management, which has led to pollution in the rivers flowing along the Nanyuki Municipality.

The manager responded by saying that he will liaise with all the stakeholders that are involved with the river protection to look at how best they can protect the rivers collectively. The manager reported that the projects and the proposals that will be raised today will be prioritized in conjunction with other projects that were raised in the last public fora held on 3<sup>rd</sup> October 2024.

#### **MIN 06/9/25: PRIOTIZATION OF PROJECTS**

During the meeting, the citizens raised the following interventions that they felt will have impacts within Nanyuki town. Initially, the projects were raised in no particular order, but later, the citizens prioritized the projects according to what they felt as the priorities.

#### **Citizens raised the following concerns on projects:**

1. Proposal of Nanyuki Social Hall renovation.
2. Proposal of Annual land rate to remain ksh1000 for plots in Likii village.
3. Citizen complained about activities at KCC that were polluting the environment.
4. BodaBoda Riders proposed construction of BodaBoda shed at the Nanyuki main market.
5. A member of the public proposed that Public Utility Lands which are currently under private use should be reclaimed including roads.
6. Adoption of a sport to be facilitated by the municipality.

7. A member of the public proposed the relocating goat Market from a private property to Public Market near the main slaughterhouse.
8. A member proposed creation of a youth hub with installation of public Wi-Fi at the Nanyuki Social Hall buildings that have not been in use for more than 10 years.
9. Proposal of a new fire engine in Nanyuki municipality.
10. A member proposed the naming of Majengo roads.
11. Members of the public demanded the demolition of unapproved kiosks/stalls sprawling within the Matatu bus park. (Matanya).
12. Members expressed their concern over security in parking areas around the market.
13. Members of the public proposed that construction and rehabilitation of public toilets to accommodate PWD.
14. Members of the public proposed the rehabilitation of Nanyuki Bus-Park with its kiosks, with a citizen asking for the inclusion of Matanya Stage.
15. Other Proposals are from the last Citizen Fora.

#### **MIN/NMB/07/9/25-PROJECTS PRIORITY AS PER THE CITIZENS**

Depending on the availability of funds and the size of the projects, the members of public voted to have the projects priority list as follows:

1. The completion of Nanyuki Bus Park, including rehabilitation of Matanya Bus Park.
2. Installation of street lights in Nanyuki.
3. Rehabilitation and upgrading of Nanyuki Stadium and Nanyuki Social Hall.
4. Upgrading of Grogon Area Roads.
5. Rehabilitation of the Nanyuki Slaughterhouse.
6. Rehabilitation of drainage systems within the Municipality.
7. Upgrading of the Nanyuki Dumpsite.

#### **MIN/NMB/ 08/9/25: QUESTIONS AND ANSWERS FROM THE CITIZENS**

A number of issues were raised by the citizens, and the following questions were presented:

- **A member no.13/8 (Likii Ward)** requested the renovation and upgrading of bridges at Simbas and Likii for improved safety. He also suggested the installation of drainage blocks to prevent frequent blockages. Additionally, he requested the installation of sewage lines, cabros, and streetlights, as well as proper waste collection in Likii. He raised concerns about the lack of transparency in the issuance of allotment letters for plots in Likii and requested that the annual land rate remain at Ksh 1,000.
- **A member no.5/17 from majengo** suggested adding more elevated water tanks at the Stage and Slaughterhouse to improve cleanliness and water storage. He also requested the rehabilitation of the Social Hall for youth activities and the construction of ablution blocks at the Stage.
- **Member no.1/8 (Representative of Nanyuki River)** requested management's attention to the maintenance and cleanliness of Nanyuki River. He also inquired if public participation had been conducted prior to the formation of Nanyuki Municipality. Furthermore, he sought clarification on how Nanyuki Municipality would address water provision in Likii and surrounding areas, where there has been ongoing water rationing. He raised concerns about the drilling of boreholes without public consent and the lack of benefits to the local community.
- **An ex administrator reg. no 10/11.** Requested that the population data be updated, proposing that a new census be conducted for more accurate planning and service delivery.

### MIN/NMB/9/9/25-RESPONSES FROM COUNTY GOVERNMENT OFFICIALS

The Manager clarified that funds allocated to Nanyuki Municipality are designated for permanent projects only. He added that the proposed projects from previous meetings will be considered during the implementation stage and will be determined by the availability of funds.

- The installation of streetlights and cabros in Likii and the hospital area will be addressed through the projects that will be funded through KUSP.
- **A senior member of the county government of laikipia (reg.1a no.1)** assured that Nanyuki River's maintenance will be prioritized. She went on further to assure the members of the public that her department will ensure during this supplementary budget her ministry will transfer the required resources to Nanyuki Municipality.
- **A senior member of the county government of Laikipia (reg.1a no 3)** assured the bodSSaboda riders that he would visit the site of the proposed location of the BodaBoda shed.
- **A senior member of the county government of Laikipia (reg.1a no.2)** responded on the issue of the fire engine and assured the members of the public that Nanyuki Municipality will receive a fire engine. He also spoke on functions and assured that all functions will be transferred during this supplementary budget.
- The Manager assured the public that all suggestions, including road improvements, waste management, and sewage lines, would be considered in the planning process.

Additional questions from the citizens included requests for:

- More ablution blocks at the market and bus park.
- Completion of market stalls and improved security.
- Improved waste management at the dumpsite, including fencing and maintaining cleanliness.
- Employment opportunities for street children to assist in waste management and recycling efforts at the dumpsites.

**Chairperson representing the Kenya National Chambers of Commerce and Industries reg no. 1/7** suggested that the County Government allocate an additional Ksh 100 million to Nanyuki Municipality to support its projects and operations, a proposal that was supported by the citizens.

Main Market Chairman, reg 1/14 proposed the addition of more ablution blocks, improved security, and more parking lots in the market area. The Market chairman proposed additional ablution blocks, security and more parking lots in the Nanyuki main market.

Anti-Corruption Representative, Laikipia County reg no 26/11. Urged that the budget allocated to the Municipality be proportional to the scale of the projects it is tasked with, ensuring no project is hindered by a lack of resources.

**MIN/NMB/ 10/9/25: ANY OTHER BUSINESS (A.O.B.)**



The citizens concerned with the environment complained about the funds provided by Financing Locally-Led Climate Action (FLLOCA) on how is being utilized and allocated. The member number 1a/1 promised to have a meeting with them on 10<sup>th</sup> January 2025 in her office.
